

**CITY OF SWISHER, IOWA
CITY COUNCIL MEETING MINUTES
JULY 14, 2025**

Mayor Brian Wernimont called the Swisher City Council meeting to order at 6:30 p.m. Council members Curt Cline, Kody Pudil, Adam Roeder, and Michael Stagg were present. Council member Daryl Hynek was absent. Also present was City Clerk Shelley Annis.

Motion Cline, 2nd Roeder to approve the agenda – all aye.

Motion Roeder, 2nd Stagg to approve the consent agenda items – all aye.

Motion Pudil, 2nd Roeder to add extra patrol by the Johnson County Sheriff's Department on Wednesday nights effective immediately. Stagg, Roeder, Cline, Pudil – aye.

Tim Cutsforth with HR Green gave the Engineer's report. Chad McCleary with Ion reported on the WWTP.

Motion Pudil, 2nd Stagg to authorize Chad McCleary with Ion to order two new pumps for the WWTP for \$12,095.60. Pudil, Cline, Roeder, Stagg – aye.

The Johnson County Treasurer, Auditor, and Attorney reported on the services their departments provide the residents and cities of Johnson County.

Clerk Annis presented an invoice as received from Lonnie Christner, 75 Howard Ave for \$1,868.14 for yard work. Council took no action to pay due to the project not being completed and overseeding being an item on the contractor's punch list.

Motion Pudil, 2nd Cline to not sell the unopened 4th Street right-of-way – all aye.

Motion Pudil, 2nd Stagg to approve Resolution 28-2025-01 approving Library employee wages for FY2026 beginning July 1, 2025 and ending June 30, 2026. Cline, Pudil, Roeder, Stagg – aye.

HR Green Engineer Tim Cutsforth reported on bids received for the 2025 Sewer Maintenance Project – Televising Region 5. HR Green recommends the Council award the project to Visu-Sewer, Pewaukee, WI.

Motion Pudil, 2nd Roeder Cline to approve Resolution 29-2025 awarding a Contract for the 2025 Sewer Maintenance Project – Televising Region 5 to Visu-Sewer, Pewaukee, WI for \$10,608.40. Pudil, Roeder, Stagg, Cline – aye.

Motion Pudil, 2nd Stagg to approve Resolution 30-2025 approving Pay App #10 for \$61,705.88 to Dave Schmitt Construction Co., Inc., Cedar Rapids, IA for work completed through June 30, 2025 on the Sanitary Sewer Project. Roeder, Pudil, Stagg, Cline – aye.

Motion Pudil, 2nd Cline to approve the 3rd Reading of Ordinance 19-2025 amending City Code Chapter 106.08-Collection Fee, increasing the monthly solid waste collection fees. Stagg, Cline, Roeder, Pudil – aye.

Motion Roeder, 2nd Stagg to place liens on properties that have not paid their past due utility account balance by July 23, 2025 – all aye.

Motion Roeder, 2nd Stagg to adjourn the meeting at 7:26 p.m. – all aye.
