

**CITY OF SWISHER, IOWA
CITY COUNCIL MEETING MINUTES
DECEMBER 9, 2024**

Mayor Pro-Tem Michael Stagg called the Swisher City Council meeting to order at 6:30 p.m. Council members Curt Cline, Daryl Hynek, Kody Pudil, Adam Roeder, and Michael Stagg were present. Also present was Public Works Superintendent Justin Fields and City Clerk Shelley Annis.

Motion Roeder, 2nd Cline to approve the agenda – all aye.

Motion Cline, 2nd Hynek to approve the consent agenda – all aye.

HR Green Engineer, Tim Cutsforth gave a verbal report.

Council discussed whether to continue with additional law enforcement on Wednesday nights and determined to discontinue for now and place back onto the February 10, 2025 agenda for consideration.

Motion Pudil, 2nd Roeder to approve Resolution 76-2024 approving final payment to the Johnson County Secondary Roads Department for \$225,283.47 for the City's portion of Construction Costs for the Division Street Improvement Project. Pudil, Roeder, Stagg, Cline, Hynek – aye.

Motion Pudil, 2nd Roeder to approve Resolution 77-2024 approving payment to the Johnson County Secondary Roads Department for \$121,056.54 for reimbursement of construction costs of the 120th Street Improvements as related to the Degen & Sheely properties to be annexed. Roeder, Stagg, Cline, Pudil-aye; Hynek-nay.

Motion Roeder, 2nd Cline to approve Resolution 81-2024 setting permit, zoning and other fees for the City of Swisher. Roeder, Stagg, Cline, Hynek, Pudil – aye.

Motion Roeder, 2nd Cline to table review of estimates for back-up emergency snow plowing until the December 23rd meeting – all aye.

Council determined to hold budget workshops beginning at 5:00 p.m. on Wednesday s beginning in January.

Council determined the need to hold a Council meeting on December 23rd.

Motion Pudil, 2nd Hynek to appoint Brian Wernimont, 74 Division St NE to fill the Mayor vacancy effective when the Oath of Office can be administered. Pudil, Roeder, Stagg, Cline, Hynek – aye.
