REGULAR CITY COUNCIL MEETING

Call to Order: Mayor Pro-Tem Mike Stagg called the meeting to order at 6:30PM.

Council Present: Kody Pudil, Brian Wernimont, Mike Stagg, Daryl Hynek, Curt Cline

Also Present: Mallorie Krob, City Clerk Bryan Miller, Public Works Superintendent

Approval of Agenda: Pudil motioned, seconded by Cline to approve the agenda. Roll Call Vote: Ayes – Wernimont, Cline, Pudil, Hynek, Stagg. Nays – None. Motion carried.

Consent Agenda: Stagg motioned, seconded by Hynek to approve the consent agenda. Roll Call Vote: Ayes – Pudil, Stagg, Hynek, Wernimont, Cline. Nays – None. Motion carried.

Public Comment: Residents from 515 Oak Ave addressed council to let them know they have had many issues over the years, but this is the first time they have turned it in to insurance. Their insurance did not cover all of the expenses. They asked that the City of Swisher be more proactive on their sewer program. City Clerk explained our budget being quadrupled in FY2027 for sewer videoing and lining to help get ahead of any further issues.

Consideration of Waiving the Second and Third Readings of Ordinance 01-2026 – Dance Halls - Discussion and possible action to suspend the rules and waive additional readings. Pudil motioned, seconded by Hynek to waive the second and third readings of Ordinance 01-2026 and place on final reading. Roll Call Vote: Ayes – Hynek, Stagg, Pudil, Wernimont, Cline. Nays – None. Motion carried.

Final Reading and Possible Adoption of Ordinance 01-2026 – Dance Halls – Discussion and possible action to place the ordinance on final passage. Tree Removal Request – Rose Ave in Front of Salon that is interfering with power lines – Cline motioned, seconded by Wernimont to check with Alliant on removal and if they decline the City of Swisher will have it removed. Roll Cal Vote: Ayes – Stagg, Hynek, Wernimont, Cline. Nays – None Abstain – Pudil. Motion carried.

Tree Removal Request – 638 Swisher View Drive – Dead Tree – Cline motioned, seconded by Stagg to have tree removed. Roll Call Vote: Ayes – Wernimont, Pudil, Cline, Stagg, Hynek Nays – None. Motion carried.
