Call to Order: Mayor Daryl Brown called the meeting to order at 6:31 PM.

Review Ordinance Change for Building With No Siding or Windows – Council reviewed and approved of new ordinance. Council would like city clerk to reach out to the City Attorney above the grass language around new developments.

Resolution 03-2026 – Adoption of City Employee Clothing Allowance Policy – Pudil motioned, seconded by Stagg to approve Resolution 03-2026 after removing “department supervisor” from language and adding in a maximum for boot reimbursement. Resolution 04-2026 – Credit Card Policy Amendment – Pudil motioned, seconded by Wernimont to approve Resolution 04-2026. Roll Call Vote: Ayes – Hynek, Stagg, Wernimont, Cline, Pudil. Nays – None. Motion carried.

Resolution 05-2026 – Approval of Change Order #1 for 2026 Sanitary Sewer Lining Region 5 – Pudil motioned, seconded by Stagg to approve Resolution 05-2026. Roll Call Vote: Stagg, Cline, Hynek, Pudil, Wernimont.

Review Resident Communication Regarding Snow Removal – Public works submitted written response to communication and a plan to avoid gaps in snow removal coverage in the future.

Resolution 06-2026 Acceptance of Swisher Pavement Rehabilitation Project 2025. This project has been completed since November and has a remaining balance of \$500 to be paid to the contractor. Stagg motioned,

seconded by Pudil to approve Resolution 06-2026. Roll Call Vote: Ayes – Pudil, Stagg, Cline, Hynek, Wernimont.
